Pink patrol system is introduced in the state as per direction of Addl. Director General of Police ,South Zone ,vide Letter No.D1/33318/SZ/16,Dated 01.06.2016 for which 2 WCPOs are to be detailed for patrolling in uniform for atleast 6 hours a day in Private / KSRTC buses ,Railway Stations,Bus Stands ,School / College premisis etc. as a part of women safety in public places .There are more than 8 WCPOs in certain police stations ,where as the strength of WCPOs is less than 4 in some police stations. In order to balance the strength position and for the smooth and effective functioning of pink patrol system, the following transfer and posting of Women Civil Police Officers are ordered with immediate effect on administrative convenience.
