Sub : Police Estt:- Seniority Dispute between AR and AP Bn Personnel – Settled – Transfer of DHQ(Reserve) personnel to Local Police- Orders issued- Reg.

Ref : (1) G O (MS) No. 37/2015/ Home dtd 26/02/2015

(2) Rule 31 of KS & SSRs

Government have accorded sanction to settle the decade long pending seniority issues between the Armed Reserve and Armed Police Battalion Personnel vide GO read as 1st paper above. The decision of the Government is as follows:

1. The benefits accruing to the police personnel by virtue of GO (MS) 125/80/Home Dated 26.12.1980 will be protected.

2. The benefit by virtue of GO (P) No. 33/89/Home dated 10.03.1989 will also be protected by temporary upgradation to those personnel who joined direct in the Armed Reserve w.e.f 17.07.1986 (till the retirement of the incumbent)/ by sanctioning supernumerary post wherever necessary.

3. There will be no reversion on account of the implementation of this order. Any other anomaly which may arise while implementing the above direction will be sorted out by temporary Upgradation / by sanctioning supernumerary posts wherever necessary.

In obedience to the above, the following CPOs of DHQ (Reserve), Alappuzha, who are eligible for transfer to Local Police are temporarily transferred to the Alappuzha district Local Police and posted to the stations / units noted against each. List of CPOs of DHQ(Reserve), Alappuzha who are temporarily transferred to Local police.



The inter-se seniority list of the above mentioned personnel will be published in due course based on the outcome of various Petitions / OAs / Cases / Appeals pending before the Hon'ble Courts and Hon'ble Kerala Administrative Tribunal. The above mentioned Local transfer are purely on temporary basis as per the provisions contained in the Rule cited above.

Officers concerned are directed to verify the above local transfer and intimate to the undersigned as to whether any eligible person is omitted from the list or whether any ineligible person is included in the list, within 15 days for rectifying the anomalies, if any.

The above orders will be subject to the outcome of the various cases pending before the Hon'ble High Court of Kerala and the Hon'ble Kerala Administrative Tribunal.

Dy. Commandant, DHQ (Reserve), Alappuzha is directed to relieve the incumbents forthwith and report compliance.
