Sub : Police Estt:- Temporary promotion of CPOs as SCPOs on the basis of GO(Ms) 37/2015 Home dated 26/02/2015- Orders issued.

Ref : 1) G O (MS) No. 37 / 2015/ Home dtd 26/02/2015.

Government have accorded sanction to settle the decade long pending seniority issues between the Armed Reserve and Armed Police Battalion Personnel vide GO read as 1st paper above. The decision of the Government is as follows.

1. The benefits accruing to the police personnel by virtue of GO (MS) 125/80/Home dated 26.12.1980 will be protected.
2. The benefit by virtue of GO (P) No. 33/89/Home dated 10.03.1989 will also be protected by temporary up gradation to those personnel who joined direct in the Armed Reserve w.e.f 17.07.1986 (till the retirement of the incumbent) by sanctioning supernumerary post wherever necessary.
3. There will be no reversion on account of the implementation of this order. Any other anomaly which may arise while implementing the above direction will be sorted out by temporary up gradation by sanctioning supernumerary posts wherever necessary.

At present, there are 13 vacancies of SCPOs in this unit arose consequent on the retirement of below mentioned 5 SCPOs on superannuation on 31.12.2017 and transfer of 8 SCPOs to SBCID Unit.



The above mentioned promotion are purely on temporary basis as per the provisions contained in the Rule cited. SHOs / Officers concerned are directed to verify the above promotion and intimate to the undersigned as to whether any eligible person is omitted from the list or whether any ineligible person is included in the list, within 15 days, for rectifying the anomalies, if any. These promotees are also liable for reversion as CPOs in the event of



any dearth of vacancies or if any person is found ineligible for promotion.

The above orders will be subject to the outcome of the various cases pending before the Hon'ble High Court of Kerala and the Hon'ble Kerala Administrative Tribunal.

Officers/SHOs concerned are directed to relieve & passport the incumbents forthwith and report compliance on their date of relief and date of joining duty in the promoted post.
