Government have accorded sanction to settle the decade long pending seniority issues between the Armed Reserve and Armed Police Battalion Personnel vide GO read as 1st paper above. The decision of the Government is as follows.

1. The benefits accruing to the police personnel by virtue of GO (MS) 125/80/Home dated 26.12.1980 will be protected.
2. The benefit by virtue of GO (P) No. 33/89/Home dated 10.03.1989 will also be protected by temporary up gradation to those personnel who joined direct in the Armed Reserve w.e.f 17.07.1986 (till the retirement of the incumbent) by sanctioning supernumerary post wherever necessary.
3. There will be no reversion on account of the implementation of this order. Any other anomaly which may arise while implementing the above direction will be sorted out by temporary up gradation by sanctioning supernumerary posts wherever necessary.

At present, there are 4 vacancies of SCPOs in this unit arose consequent on the death of 1 SCPO on 20.01.2018 and retirement of 3 SCPOs on superannuation on 31.01.2018 as furnished below.

In addition to the above, 5 vacancies of SCPOs are also existing in this unit consequent on the integration of WCPOs with main stream of police force as per the Orders contained in the Govt Orders cited 4 & 5. The vacancy details are as follows:
